# 5+5 Dialogue Third Ministerial Conference on Migration in the Western Mediterranean Algiers, 15-16 September 2004

#### **Summary of Conclusions by the Presidency**

In conformity with the recommendations of the second Ministerial Conference on Migration in the Western Mediterranean held in Rabat, on 22<sup>nd</sup> and 23<sup>rd</sup> October 2003, and at the invitation of the Minister of Youth and Sports of the Algerian Democratic and Popular Republic, the Ministers and government representatives of member States of the 5+5 dialogue framework (Algeria, Spain, France, Italy, Libya, Malta, Morocco, Mauritania, Portugal and Tunisia) met in Algiers on 15 and 16 September 2004 for the third Ministerial Conference on Migration.

The International Organisation for Migration (IOM), the International Labour Organisation (ILO) and the International Centre for Migratory Policies Development (ICMPD) participated as observers to the Conference.

This third Conference followed those held respectively on 16 and 17 October 2002 in Tunis and on 22 and 23 October 2003 in Rabat.

A preparatory experts' meeting was held on 07 and 08 July 2004 in Algiers.

As the host country of the Conference, and after consultations with the partners, Algeria, which is responsible for the Presidency and the follow-up of the cooperation framework for the year 2004-2005, has noted the following conclusions and areas of work:

- The third Algiers 5+5 Conference on migration falls within the framework of the affirmation of the Tunis Declaration that emanated from the first Ministerial Conference of the 16 and 17 October 2002, as well as in continuity of the second Ministerial Conference held in Rabat on 22 and 23 October 2003, constitutes a step towards the identification and mobilization of means necessary to achieve effective cooperative actions in the sphere of migration.
- In this respect, the ministers paid tribute to the efforts undertaken by the Tunisian and Moroccan presidencies, for the efficient coordination and follow-up work undertaken, leading to the Tunis Declaration and the actions decided upon during the Rabat Conference.
- They noted with satisfaction the important and significant results achieved by the 5+5 Summit of Heads of State and Governments (Tunis 05 and 06 December 2003), in particular the recommendations referring to the movement of persons between the two shores of the western Mediterranean, and to the necessity of undertaking joint action and concerted cooperation, including on the operational level, in this domain, with the aim of promoting a global and balanced approach to this question.

- The ministers commended all the initiatives undertaken by their colleagues, ministers of the interior of western Mediterranean countries, towards strengthened cooperation through prevention and combating irregular migration and traffic of human beings. They supported supplementing these initiatives with any useful and complementary actions including that of developing regions with a high migratory potential.
- The ministers also underscored the necessity of examining thoroughly and developing a conceptual approach to migratory questions, based on friendship, solidarity and cooperation, through the establishment of a partnership liable to consolidate the process of bringing peoples of the region closer together. Such an approach would also encourage a concerted treatment of the effects and undesirable consequences of migration.
- Recalling, in this respect, the dynamic link that should exist between the 5+5 framework for political cooperation and consultation and the Barcelona Process, the ministers stressed the pertinence of the framework document conclusions adopted by the Barcelona Process on the regional programme Justice and Internal Affairs. Such a document clearly sets out the need, in all forms of cooperation between the two shores of the Mediterranean, of including dialogue and consultation with a global, balanced and integrated vision, including the social dimension of migration.
- While recognizing the importance of establishing the 5+5 cooperation framework, the ministers, nevertheless, recalled their attachment to bilateral cooperation with regards to the management of migrations. The latter should develop harmoniously and in synergy with the other multilateral cooperation frameworks.
- The ministers also referred to the question of the enlargement of the European Union and agreed to continue close and sustained cooperation on the subject of migration and the movement of persons between countries of the North and South of the Mediterranean.

The ministers also recommended increased cooperation in the form of actions in the following spheres:

- A. Strengthening of cooperation with regards to the exchange of information on migratory questions through the establishment of a network of focal points on the subject;
- B. Organisation of meetings and seminars for experts from the Northern and Southern shores responsible for the management and processing of migratory flows according to a periodicity agreed upon by the States party to the dialogue;
- C. Initiation of awareness building campaigns on migration as well as on the risks and dangers of clandestine immigration. These actions, that should be highly visible, could be undertaken with the voluntary financial contribution of the States participating in the 5+5 dialogue and, possibly, of international organisations;
- D. Encouraging the emergence in countries of the south, of competent structures in the field of research and analysis of data on migratory flows:
- E. Carrying out, in each partner country concerned, of studies on regions with a high migratory potential, with a view, in particular, of coordinating national policies in this domain. To this end, particular

attention will be granted to priority issues and programmes aiming at combating poverty and stabilizing persons, in order to carry out development projects in the southern boarder areas of the countries of the southern shore of the Mediterranean to combat irregular migration towards the north.

- F. Search for new forms of cooperation, based on the use, in the States of origin, of human skills from the countries of the South established in the countries of the northern Mediterranean;
- G. Promotion of new forms of managing migrations within the framework of bilateral cooperation between member countries of the 5+5 dialogue framework with regards to jobs, including through:
- The establishment of vocational training projects in the migrants' countries of origin to promote a better match between the offer and the demand for jobs as well as to improve the integration of migrant workers in the receiving country;
- -The conclusion of agreements for the exchange of young professionals to perfect their linguistic and professional skills and to acquire an experience of salaried employment in another country.

The ministers also recalled that proper management of migration will lead to the strengthening of ties of friendship between peoples of the region and that in this specific context, the circulation of persons between the two shores of the Mediterranean should retain the undivided attention and solicitude of the authorities of the partner States to the 5+5 dialogue.

On the whole, and in view of the extreme complexity of the migration issue, in particular with regards to the fact that it creates intense and renewed ties between several regions of the world, the ministers considered that the debate on this question must necessarily, and according to concerted and appropriate mechanisms, be enlarged to include the neighbouring countries from sub-Saharan Africa, also concerned by irregular migration. In this context, the ministers recommended that the terms of reference for a consultation with all the countries of the region be drawn up, in order to ensure a global and harmonious treatment of the question.

With a concern to proceed to concrete action in the areas included within the cooperation framework, and in view of the utmost importance of the question of their funding, the ministers agreed to explore together the ways and means of responding to this requirement.

To this end, they decided to set up a high level group to follow-up the 5+5 ministerial conference on migration, coordinated by the serving Presidency . Amongst other tasks, the group will be responsible for:

- Identifying and reinforcing concrete cooperative actions;
- Identifying and mobilizing existing capacities in terms of expertise and funding;
- Examining the financing possibilities available within the framework of European Union instruments and of expertise and technical assistance offered by organisations such as ILO, IOM and ICMPD.

The delegations commended the efforts made by Algeria to present a work platform aimed at reaching further stages in the process of crystallizing the different directions and conclusions of cooperation agreed upon.

They also expressed their thanks to Algeria for the welcome and hospitality they received during this conference.

At the proposal of the French delegation, the next Ministerial Conference on Migration in the Western Mediterranean will be held in France in October 2005.
